 - The Workshop "Establishing Partnerships in the field of Dual Education" was organized within WP4. During the process of organizing and preparing, the owners of small and medium-sized enterprises, as well as representatives of schools, representatives of the city administration.

 - The workshops were attended by the director of the Chamber of Commerce of Serbia-Regional Chamber of Commerce Kraljevo, the Deputy Mayor of the city of Cacak, the representatives of the City Administration of the city of Cacak, as well as representatives of companies and secondary vocational schools from Cacak, Kraljevo, Novi Pazar.
 - The workshop was not attended by representatives of the Ministry. Their presence was confirmed for the next workshop that will be held in December.

 - All activities from the WP33 level were used in further work. The knowledge and skills we have gained at the negotiation and advocacy workshop, but also the experience and information during the round tables and meetings, are especially important. An important aspect of the experience is also elements from the strategy of dual education development and action plan.

 - The biggest problem of the process of planning the workshop was holidays. Namely, July and August is the time when a large number of owners of small and medium-sized enterprises, and as well as all participants in general, are on holiday.

The workshop "Establishing Partnerships in the field of Dual Education" within the EP4A project "European Partnerships for Apprenticeships" was organized with the aim of presenting the project and presenting a needs analysis in the field of dual education in Republica Serbia.

- What topics did your workshop include?

The workshop covered topics such as:

• What obstacles to involving employers into the dual education system,





- The advantages of the same system and
- Recommendations for the quality establishment of cooperation between educational institutions and the economy
- Implementation of dual education in Serbia
- What techniques and methods did you use?

The methodology of the workshop included interaction among participants, answers to questions of small and medium-sized enterprises owners, exchange of experiences and examples of good practice

- Key outcomes/Achievements/Outputs/Feedback by participants

In the territory of the Raska and Moravica Administrative District for the next school year, classes for students who decided to educate themselves in dual model of education, will be realized in Cacak, Novi Pazar and Sjenica for fashion tailors, in Kraljevo for furniture operators and in Kraljevo and Cacak for traders by dual.

Participants of the workshop determined the good sides of dual education through the discussion, the challenges with which professional practice meets and suggests potential solutions. It was emphasized the importance of communication between all participants in the establishment of a higher quality apprenticeship, which makes this project possible.

At the end of the workshop, a Contract on performing apprenticeships was signed. Contract was signed between the Mechanical-Technical School from Cacak with the companies Weltex d.o.o., Tiffaniy Production and P.S Fashion d.o.o. from Cacak, for the period from 2017 to 2020. This contract will be the basis for carrying out practical classes during the three year education of students for the educational profile fashion tailor.

The workshops were attended by the director of the Chamber of Commerce of Serbia-Regional Chamber of Commerce Kraljevo, the Deputy Mayor of the city of Cacak, the representatives of the City Administration of the city of Cacak, as well as representatives of companies and secondary vocational schools from Cacak, Kraljevo, Novi Pazar. The workshops were also attended by the owners of small and medium enterprises.

- What experiences from the WP3 Capacity building activities did you use in your delivery?

All parts of capacity building activities, from a theoretical and practical aspect, have been provided as a basis and a good experience for further action towards the realization of the project.

- Identify barriers you faced during the delivery of Workshops?

The biggest problem and barrier we face in contact with the owners of small and medium enterprises is the insufficiently developed awareness of the long-term benefits, importance and importance of dual education.
